



CUDIA CITY WASH DESIGN CONCEPT REPORT

The Flood Control District of Maricopa County, in collaboration with the City of Phoenix and Town of Paradise Valley, is conducting the Cudia City Wash Design Concept Report (DCR).

Study Area

The Cudia City Wash area, more commonly known as Echo Canyon Wash, focuses on an area encompassed by Tatum Blvd to Stanford Drive between 38th and 52nd Streets. The limits of the DCR are shown on the map.

How Could the Project Affect You?

The primary goal of the DCR is to update and refine findings identified in the area drainage master study completed in March 2020.

Preliminary floodplain delineation and mitigation alternatives have been identified and evaluation is underway. The floodplain evaluation determined there will be a benefit to re-delineate the Cudia City Wash and revise the Flood Insurance Rate Maps (FIRM). That process has been started and the new floodplain will better depict the flood hazards along the Cudia City Wash.

We Need Your Input

Community involvement is essential for the success of the study. The DCR study will include stakeholder input to prioritize future



capital improvement projects when funding becomes available. Area residents have valuable experience and knowledge that positively improves the study's success.

This virtual public presentation provides information about the floodplain re-delineation along with an opportunity to evaluate and prioritize alternatives for the Cudia City Wash.
